The information we collect:

We collect details from you when you register for a trial on our website. The information collected is contact information such as your name, email address and phone number. Information from social media activity (such as likes, shares and tweets) when you interact with us on social media; information you provide if you report a problem with our website or service; additional information which you provide voluntarily and/or which we may ask from you to better understand you and your interests.

We also collect information from you through cookies when you visit our website. This information is things like your IP address, the device you're using and areas of the site that you've visited.

We use Google for targeted advertising. Once you've visited our website, you may notice that you see ads for SortMyBooks when you're browsing other websites. This is due to a feature called Google Remarketing. Google tracks your web browsing, again using cookies, and then displays ads based on your browsing history. If you hover your mouse (don't click) over an ad, you'll see a little triangle that says 'Ad Choices', you can turn any particular ad off and even click on a link called Set Your Ad Preferences.

What we do with that information:

We use your information to send you details on how SortMyBooks works. We also send out newsletters from time to time with articles relevant to businesses and for
